### Exhibitors Note:

Judges are not required to wait for dogs. Judges will break at their discretion.

Transfers will be accepted per AKC regulations. Completed transfer form must be submitted to the Trial Secretary no later than 30 minutes prior to the start of judging.

All Rally classes begin with a walkthrough, which is combined for A & B classes when there are no more than 20 total entries.

Some Obedience classes begin with a briefing. The briefing is combined for Beginner Novice A & B. Running order is forward catalog order (low to high jump height) in all classes.
