WAIVER, RELEASE AND ACKNOWLEDGEMENT OF ASSUMPTION OF RISK

In consideration of the enrollment for training, and as an inducement to my participation in ADTC classes or activities, I hereby waive, release, discharge, and covenant not to sue ADTC, its officers, members and/or agents from any and all liability of any nature, for injury or damage which I, my dog, or any family member may sustain, including specifically, but without limitation, any injury or damage caused by the action of another dog or by participation in the foregoing activities.

In consideration of the enrollment for training and as an inducement to my participation in ADTC classes or activities, I additionally hereby agree to indemnify and hold harmless the ADTC, its officers, members and agents, of and from any and all claims, causes of action, losses, damages, judgments, costs, or expenses, including attorneys' fees, which in any way arise from my or my family members or guests' acts, omissions and/or negligence, irrespective of whether the acts, omissions and/or negligence of the ADTC, its officers, members and agents, or any third party contributed to the loss.
