Classes with jumps will run in **ascending jump height order**.

Judges are not required to wait for dogs. The owner or handler is responsible for having the dog at ringside when its number is called.

Refunds for bitches in season less \$7 per entry with veterinarian's note.
To request an in-season refund, contact the ADTC Trial Secretary.

All dogs present must be on leash except when being judged in the ring.

Only entered dogs are permitted inside the trial.
